// NOTICE //

WHEREAS, No.08120430 Rfn(GD) Ajit Kumar Pathak of 1st Bn TSR proceeded on 15(fifteen) days Casual Leave w.e.f.18.03.2016 to 10.04.2016. But, after expiry of the said leave, he did not turn up his duty and has been overstaying beyond the period of sanctioned leave w.e.f.10.04.2016 to till date without prior permission of the competent authority, which is pre-judicial to good order and discipline, being a member of the Rifles under section-12(1) of the TSR ACT,1983.

AND WHEREAS, the following notices were issued to him at his home address recorded in his service book to join his duty immediately. But, he did not join his duty till date. Copies of the said notices were sent to concerned PS for causing service to the said Rfn(GD) Ajit Kumar Pathak at his home address. Neither acknowledgement receipt of the said notices has been received from Rfn(GD) Ajit Kumar Pathak nor his concerned PS (i.e. Buxar Police Station) till date.

AND WHEREAS, a Memorandum vide No.9453/F.Pers/TSR-1/Estt/AKP/2008 dt.16.12.2016 alongwith annexures- I, II, III & IV were issued to No.08120430 Rfn(GD) Ajit Kumar Pathak at his home address through registered with A/D wherein he was directed to submit within 10 days' on receipt of this Memorandum a written statement of his defence and also to state whether he desires to be heard in person. But, till date no acknowledgement receipt of the said memorandum has been received from him. The said Memorandum was sent to Officer-In-Charge, Buxar Police Station, Bihar for causing service to the said Rfn(GD) Ajit Kumar Pathak on proper receipt vide this office letter No.9524/F.Pers/TSR-1/Estt/AKP/2008 dt.20.12.2016, No.1056/F.Pers/TSR-1/Estt/AKP/2008 dt. 13.02.17, No.3096/F.Pers/TSR-1/Estt/AKP/2008 dt.04.05.2017, No.4866/F.Pers/ TSR-1/Estt/AKP/2008 dt.06.07.17 and No.7624/F.Pers/TSR-1/Estt/AKP/2008 dt.04.09.2017. But, till date, no reply has been received from O/C Buxar Police Station, Bihar.

AND WHEREAS, Besides this, the following letters were sent to the Station House Officer, Industrial PS (SI Jitendra Kumar) Dist- Buaxr, State-Bihar and Officer-in-charge, Buxar Police Station with request to issue a certificate to this office that the whereabouts of Shri Ajit Kumar Pathak ,Rfn(GD),1st Bn TSR is not known. But, till date, no reply has been received from Officer-In-Charge of Buxar Police Station, Bihar.

AND WHEREAS, On 17.01.2017, he has submitted an application dated Nil alongwith medical documents of his wife & daughter 8.5 months) wherein he stated that he could not join duty due to his wife & daughter treatment. In this respect, a notice vide No.7644/F.Pers/TSR-1/Estt/AKP/2008 dated 06.09.2017 has been issued to Rfn(GD) Ajit Kumar Pathak of 1st Bn TSR at his home address through registered with A/D directing him to join his duty immediately at BN Hqr, 1st Bn TSR, Gokulnagar. But, neither did he join his duty nor any response has been received from him till date.

NOW, THEREFORE, the said Rfn (GD) Ajit Kumar Pathak of 1st Bn TSR S/O:-Shri Bindhyachyal Pathak of Vill-Sohani Patti Ward No.21, PO:-Sohani Patti, PS:-Buxar Town, Dist:-Buxar, Bihar, PIN-802101 is hereby given last chance/ opportunity to join his duties with explanation of such overstaying beyond the period of sanctioned leave w.e.f.10.04.2016 to till date within 15 days from the date of publication of this notice in newspapers, failing which the department will take stern disciplinary action against the said Rfn(GD) Ajit Kumar Pathak as per Rule-19(ii) of CCS(CCA)Rules,1965 and Rule-42(i) of the TSR(DCSC etc)Rudles,1986.
