TERMS & CONDITION

On behalf of the Governor of Tripura Sealed Tender is invited for sale of the under-noted Condemned vehicle bearing registration No. TRP-239 (1210 TATA Truck) of Principal, KTDS, PTA, Narshinghar, Tripura, Agartala on “**AS IS WHERE IS BASIS**”.

2. Intending buyers may please furnish bids in **Sealed Covers** to be sent by Registered/Speed Post or by hand to the undersigned. Sealed tenders are to be accompanied by **20% of total tendered value** as Earnest Money in the shape of **deposit at call only** in favour of the Principal, KTDS, PTA, Narshinghar, Tripura, Agartala on any **Nationalized Bank** having branch at Agartala. Sealed tenders should reach this office on or before 01.06.2018 at 1600 hrs.

The tender, will be opened at this office on 01.06.2018 at 1700 hrs. The tenderer(s) or his authorized representative(s) may remain present, if they like. The sealed covers containing the bids should be super scribed in **bold letters with following words “TENDER FOR PURCHASE OF CONDEMNED VEHICLE DUE ON 01/06/2018 ”or the same shall be summarily rejected.**

3. The intending buyers may inspect the condemned vehicle mentioned above from 1000 hrs. to 1730 hrs. of any working day from 25/05/2018 to 31/05/2018.

4. The undersigned reserve, the right to accept or reject any tender rate including the highest one with assigning any reason thereof.

5. Rate is liable to be rejected summarily for not fulfilling any of the conditioned given below:-

6. No rate(s) will be accepted without the required amount of Earnest money.

7. Rate(s) offered should be written legibly **both in figures and words**. Any overwriting/ erasing/ illegible writing will not be allowed and in such circumstances, **the tender will be rejected**.
8. The successful bidders shall have to deposit the entire amount within **07(seven) days** from the date of issue of the acceptance letter and arrange to remove the vehicle(s) **within 03(three) days** from the date of depositing the bid money, **failing which, Earnest money will be forfeited**.
9. Sale, tax or any other tax (GST), if any applicable as per rules on account of disposal/sale of the condemned vehicles will be charged on the successful tenderer and they should pay the same charges to the appropriate taxing authority and the documents of such payment should be submitted to the undersigned **within 03(three) days** from the date of issuance of acceptance letter, **failing which, Earnest money will be forfeited**.
10. Earnest money of the 1st, 2nd and 3rd highest bidder will not be released till delivery of the condemned vehicles and that of the others i.e. 4th, 5th, 6th highest bidder etc will be released after the selection of 1st, 2nd and 3rd highest bidder.
